At its meeting of September 1, 1998, the Design Review Board took the following action on your submission:

Approved replacement windows (Sugarcreek Industries slider windows in Bronze) for general use in the cluster due to their conformity with the criteria of the previously approved window replacement standards dated May 7, 1996 which required the following:

- a. that all configurations and sizes exactly match the existing windows;
- b. that the frame color exactly match the existing and be metal clad "bronze tone" (not wood or vinyl); and
- that all operable sections may be casement or slider, and lower horizontal section may be fixed or awning.


At its meeting of May 7, 1996, the Design Review Board took the following action on your submission:

Approved window replacement (Craftline Clad casement windows or Craftline Clad sliding windows in "brown/bronze") with the stipulation that all configurations and sizes exactly match the existing windows.

By this decision, the DRB established cluster standards for window replacement in Colts Neck Cluster as follows:

- a. that all configurations and sizes exactly match the existing windows;
- b. that the frame color exactly match the existing and be <u>metal clad</u> "bronze tone" (not wood or vinyl);
- c. that all operable sections may be casement or slider, and lower horizontal section may be fixed or awning; and




